# TOWN OF CLARKSON PLANNING BOARD Meeting Minutes April 2, 2019

## CALL TO ORDER

Conrad Ziarniak called the meeting to order at 7:00 p.m. and led all those present in the Pledge of Allegiance with a moment of silence honoring Veterans, military service members and first responders. Conrad Ziarniak read aloud the agenda.

#### **PUBLIC HEARING**

Applicant: Steve Kepler Property Owner: Franklin and Donna Kepler Property Address: 389 East Avenue, Brockport, NY 14420 Tax ID#: 069.06-1-7 Zoning: Incentive Zoning, RS 10

Conrad Ziarniak opened the public hearing with reading of the legal notice for the subdivision of approximately 21.1 acres of land into two parcels. Rich Maier of Maier Land Surveyor discussed the project. R. Olson stated that an easement is needed for the Ingress/egress driveway water, sewer and electric. Approval is needed by the Monroe County DRC. No comments from the public.

Rich Maier will have Kevin Moore sign the DRC so it can be submitted to the county. Application will be on the agenda for the next meeting.

Discussion regarding Paul Neefe-Evergreen Landscape Application

Paul Neefe explained application is two-part. The first is to replace a bin that was blown down in a recent storm. The new bin which is a three-sided structure will be smaller and sturdier than the previous bin. The second part of the application is to combine two pieces of property into one.

Motion by D. Virgilio Seconded by J. Jackson To waive further site plan review per Clarkson Town Code §116-25 and grant minor subdivision approval. Approved unanimously

#### Newman Application

The Newman Application request for a Special Use Permit had approval pending approval of the Town Attorney. This condition has been met. R. Olsen has reviewed and has approved.

#### **Baase Application**

J.P. Schepp reviewed the plans of the Baase Application and had recommended changes. Kevin Moore has talked to the applicant and applicant has acknowledged that they received the recommendations. It was noted that the plans do not include any water. The applicant has been working with Monroe County water authority. Review is needed by the Department of Health and the Monroe Country DRC. Applicant was not present at the meeting. Motion continues to be tabled.
