Supervisor Filipowicz opened the meeting. Sharon Mattison, Town Clerk led all those present in the Pledge of Allegiance. A moment of silence was observed for our service men and women, first responders and those that paid the ultimate price.

OPEN FORUM

James Schmidt of 315 Chadlee Drive questioned the availability of legal notices. Supervisor Filipowicz stated that they are in the *Hamlin Clarkson Herald*, the Town's legal newspaper, and on the Town website. If he did not see it on our website it is due to a glitch we had with the website.

Supervisor Filipowicz introduced Deputy Town Attorney, Keith O'Toole and stated Councilperson Zink, Bldg. Insp. Kevin Moore, Assessor Liz Spencer and Attorney Richard Olson were excused this evening.

PUBLIC HEARING, INTRODUCTORY LOCAL LAW #1; DOG LICENSING AND CONTROL LAW

Attorney, Keith O'Toole explained that Introductory Local Law #1 includes amendments to the existing Dog Control Law. It establishes a cap of three dogs per household, exempts puppies under age of six months and permitted kennels. There will be a grandfather provision on the dog ownership cap for dogs owned and licensed in Clarkson prior to the effective date of the law. In addition, it amends notice provisions for dogs that are seized by the Town which have been abandoned or seized due to an incident. The notice provisions are being put into place to harmonize those found in the N. Y. State Dept. of Ag. and Markets Law.

Supervisor Filipowicz proposed the effective date of September 1, 2019, to allow dogs already owned and licensed to be grandfathered.

Section 1. That the Town Board of the Town of Clarkson classifies this as an Unlisted Action and makes a determination of no significant environmental impact.

<u>RESOLUTION#169</u> <u>ADOPTING LOCAL LAW #1-2019; A LOCAL LAW TO AMEND THE</u> <u>TOWN OF CLARKSON'S "DOG LICENSING AND CONTROL LAW</u> <u>OF THE TOWN OF CLARKSON"</u>

Introduced by: Councilperson Didas Seconded by: Councilperson Smith

WHEREAS, the Town Board has before it a Local Law entitled " Local Law #1-2019 "A local law to amend the Town of Clarkson's "Dog Licensing and Control Law of the Town of Clarkson"

which, if adopted, will restrict the number of dogs per household to three dogs, and permits dogs to be exempt from this restriction if they are duly licensed no later than September 1, 2019. It also amends the redemption period and notice provisions for dogs that have been abandoned or seized; and

WHEREAS, the Town Board has, pursuant to law, held public hearings to consider said proposed Local Law; and

WHEREAS, this action was classified as an Unlisted action under the State Environmental Quality Review Act and the Town Board made a finding of no significant environmental impact and adopted a negative declaration; and

WHEREAS, the notice of this hearing was duly published and posted as required by law;

NOW, THEREFORE, BE IT RESOLVED:

Section 1. That the Town Board of the Town of Clarkson hereby enacts Local Law #1-2019 "A local law to amend the Town of Clarkson's "Dog Licensing and Control Law of the Town of Clarkson""

Section 2. That the Town Clerk is ordered to publish a legal notice indicating the adoption of this Local Law and to file a copy of this Local Law with New York State.

Section 3. That this Local Law shall take effect immediately.

RESOLUTION #170 REQUIRING CUTTING OF GRASS

WHEREAS, the Town Board has received a report from Kevin Moore, Building Inspector that property at 40 Woodstock Lane, Clarkson, NY has an unhealthful and dangerous condition, to wit high grass and weeds; and

WHEREAS, the Town Board has reviewed this report and determined that the allegations contained therein are accurate; and

WHEREAS, pursuant to Local Law #2-2009, "Removal of Brush, Grass, Rubbish or Weeds and Spraying of Poisonous Shrubs or Weeds Law of the Town of Clarkson" this board may direct the property owner to remedy this condition and if such condition is not remedied within ten (10) days, have the condition remedied by the Town with the cost thereof to be assessed to the property;

NOW, THEREFORE, BE IT RESOLVED:

Section 1. That the Building Inspector is directed to mail and post the notice as set forth in Local Law #2-2009;

Section 2. That if the condition is not remedied within ten (10) days of the notice, the Building Inspector shall notify the Highway Superintendent who is directed to take appropriate action to remedy the condition;

Section 3. That this resolution shall take effect immediately.

RESOLUTION #171 REGARDING PROPOSED WATER SERVICE CONNECTIONS WITHIN MONROE COUNTY AGRICULTURAL DISTRICT NO. 5

WHEREAS, the Town Board of the Town of Clarkson has created the Rt. 18 Clarkson Hamlin Water District pursuant to Town Law for the express purpose of providing public water supply to the residents of the District; and

WHEREAS, all of the land area within the proposed Rt. 18 Clarkson Hamlin Joint Water District is also within the Monroe County Agricultural District No. 5; and

WHEREAS, the Town Board has filed a Notice of Intent to undertake an action within an agricultural district and to evaluate the impact of providing a source of public water supply within this area on lands within Monroe County Agricultural District No. 5

NOW, THEREFORE, BE IT RESOLVED; that the Town Board of the Town of Clarkson, hereby resolves to limit connections to the public water supply only to existing non-farm uses, and to farm related uses within that portion of Rt. 18 Clarkson Hamlin Joint Water District which is within the limits of Monroe County Agricultural District No. 5.

LOCAL LAW # 1-2019 TOWN OF CLARKSON, MONROE COUNTY

A LOCAL LAW TO AMEND THE TOWN OF CLARKSON'S "DOG LICENSING AND CONTROL LAW"

Be it enacted by the Town Board of the Town of Clarkson.

Section 1. New Matter. Chapter 56 of the Code of the Town of Clarkson entitled "Dog Licensing and Control Law of the Town of Clarkson" is amended by adding the following:

§_____ Number of Dogs Restricted.

- A. No person or persons living in the same household, living unit, apartment, trailer or other dwelling shall keep or suffer to be kept more than three dogs, six months old or older, at any one time on said premises, excepting here-from those persons operating an Animal Kennel.
- B. Exemption from Restriction. Any dog duly licensed on or before September 1, 2019 shall be exempt from the aforesaid numerical restriction.

Section 2. Repealer. The following provisions of Chapter 56 of the Code of the Town of Clarkson entitled ""Dog Licensing and Control Law of the Town of Clarkson" are repealed:

§56-12(A)

Section 3. New Matter. Chapter 56 of the Code of the Town of Clarkson entitled "Dog Licensing and Control Law of the Town of Clarkson" is amended by adding the following:

§56-12(A)

A. In the event that the dog seized bears a license tag, the authorized person seizing the dog shall, within three days thereafter, ascertain the name of the owner and give the owner immediate notice by serving upon the owner personally, or by certified mail return receipt requested, an instrument in writing stating that the dog has been seized, indicating when, where and why the dog was seized and stating that the dog will be disposed of unless it is redeemed or a trial is demanded. If the instrument in writing has been served personally on the owner, then the owner will have 5 days after day of notice to redeem the dog or demand a trial. If the instrument in writing has been served personal a trial.

Section 4. Effective Date.

This local law shall take effect immediately.
