<u>2-09-2021</u>

Supervisor Report: Supervisor Filipowicz advised that Al Hammel is partnering with the Brockport Fire Department Station #2 and the possibility of an electric car charging station at that location. This would be universal to all electronic cars. It would be located at Station #2 where it is close to the parks, court and the Clarkson Fire Department. Something similar is being used in the Buffalo. They are looking into a possible grant. Residents Todd and Charlene Smith of Laura Lane have contacted the County regarding water breaks that continue to evolve on their street. The county is monitoring the situation as the town does not work on these water lines. There is a proposal for amending the America Tower Agreement.

Town Board Report: Leslie Zink attended a Brockport Village Board Meeting where the Greater Brockport Community Award was being presented to Dr. Heidi MacPherson. The openings on the ARB and the Conservation Board have now been filled and we have training set up for the Conservation Board in early March. Dick Olsen will be conducting this meeting. In discussing Clarkson Good Neighbor Days, Leslie brought up the possibilities of some changes to movie time, band and fireworks. Maybe even doing movie night during the week prior to the actual event. Leslie has been in contact with Supervisor Eric Peterson from Hamlin regarding the use of the movie screen. Also discussed perhaps a car show and food service with the Lions Club. Tom Guarino advised that the Sweden Clarkson Recreation Center boys and girls' baseball and softball sign-ups end on February 11. They are looking for qualified coaches for all as well as searching for referees. They are paid positions for referees 15 years old and above.

<u>Assessor's Report:</u> Liz Spencer advised that the preliminary residential LOA- Level of Assessment rate is down to 91.3%, and commercial and farmland is at 96%. Housing sales have appreciated quite a bit in Clarkson over the last couple of years. Liz is projecting to re-assess in 2022. She advises that the equalization rate will drop to 95% based on sales and market. The goal is to be at 100% equalization rate for housing.

Highway Report: Bob Viscardi advised that the floor at Kimball Lodge is in need of repair. Painting the floor is an option. Bob feels that it would cost approx. \$2500 to put down tile flooring. Epoxy floor was discussed as it looks great and is long lasting. Bob will look into it and advise costs. He advised that 8 GPS units were going in to the highway vehicles on February 10, 2021. Once completed he will send all information to Tom Guarino and Bob will set up training. Bob also advised that the ice rink is poured and set and people have already been using it. The rink has lights and is open until 10p. Bob also mentioned that Clarkson has used 1200 tons of salt, miles driven for highway salt trucks is 20,560, and recorded 2,231 hours.

<u>**Town Clerk Report:**</u> Susan Henshaw discussed that she has collected \$4.6 million in Town and County taxes, out of the \$5.78 million due. That we are up to 23 lodge rentals for 2021. We have sold 393 Transfer Station permits to date. This Saturday February 13 is the last Saturday we are open to assist with Town and County taxes as well as other residential needs.
