Supervisor Filipowicz opened the meeting. She led everyone in the Pledge of Allegiance. A moment of silence was observed for our service men and women, first responders and veterans, particularly those who have paid the ultimate price.

OPEN FORUM

Dana Merchant of 6 Scarlet Pine Circle, wanted to discuss her concerns with the amount of traffic and the speed limit on Gilmore Road. She also wanted to mention how a stop sign at the corner of Gilmore Road and Scarlet Pine Circle would be advantageous due to the view obstruction from guardrail that is over the creek on Gilmore Road. She advises the guardrail seems to block her sight and is difficult to see oncoming traffic at times until it is in front of you. She has safety concerns regarding possible accidents in that area. Attorney Richard Olson advised that the state controls the speed limit signs on that road. Years ago, the town board asked the state to do a study in that area with the possibility of reducing the speed. The state did their study but would not change the speed limit. Councilperson Guarino will reach out once again to the state and advise the concerns.

HISTORICAL MOMENTS

Town Historian Leanna Hale mentioned that she hosted 2 classes on Pioneer Day at the Clarkson Schoolhouse. She is hoping that this will once again be a permanent event for the schools to attend. Leanna then spoke about Moody Freeman - who was one of the first settlers in Clarkson back in 1803. His son Calvin did an interview for the newspaper in 1869, and Leanna wanted to share a portion of that interview. It advised how Moody Freeman came to, at the time, Genesee County, now Monroe County, in 1803 and specifically into the town of North Hampton, now Clarkson. He occupied land 1.5 miles north of Clarkson village. Calvin found his way to the Town of Sweden and purchased 2 lots there, near the railroad tracks. Both were the first dwellings in either town. The nearest neighbor lived 18 miles south in LeRoy. He wrote about how they built their homes, floors and fireplaces. Once the houses were completed, they began their journey to their neighbor, in LeRoy. The adventure took them through heavy rain and a snowstorm that was knee deep. They finally arrived to their neighbors' house, William Marsh, where they stayed overnight. The next morning, they started their passage back home. The next morning both men returned home. For the next 1.5 years, Calvin worked, helped his father to grow many crops and helped his brother, Jedothan, move his family more into the wilderness. Once the family was finally altogether, Moody Freeman reflected on his many blessings and was so very thankful to begin their life in a new country with no known inhabitants within 18 miles.
